Mission Statement:

The mission of the National Joint Committee on Learning Disabilities (NJCLD) is to provide multiorganizational leadership and resources to benefit individuals with learning disabilities.

To pursue its mission, the NJCLD will:

- Facilitate communication, collaboration, and consensus among member organizations.
- Identify and address needs in research, policy, and professional education and development related to learning disabilities.
- Provide an interdisciplinary forum to increase communication and understanding among educational organizations, community, and governmental agencies at the national, state, and local levels.
- Act as an advocate and make recommendations on key issues affecting individuals with learning disabilities.
- Develop and disseminate statements, reports, and other resources in the area of learning disabilities to clarify issues, influence policy, improve practice, and increase knowledge.

Meetings: The NJCLD meets twice a year to consider contemporary issues in learning disabilities, and to develop and disseminate reports and statements related to these issues.

Funding: The NJCLD is supported by contributions from the member organizations.

Membership: The NJCLD is a national committee representing 12 organizations concerned about individuals with learning disabilities that has been in existence since 1975.
